1. Introduction

The “Rate Card” contains comprehensive list of services and its rates provided by Kuehne+Nagel as from the goods arrival in UAE through Dubai International Airport (DXB) or Al Maktoum International Airport (DWC), or by vessel to Jebel Ali Sea Port (AEJEA) till delivery to the COP28 venue, and from the venue until goods are loaded on any mode of transport for re-export. 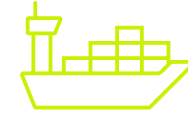

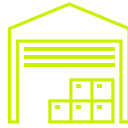

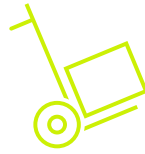

5. Handling Courier shipments.



COURIER HANDLING CHARGES:

- Min. USD 75.00 per consignment (1st package).
 - Thereafter USD15.00 per each additional package.
 - Each package with a maximum of 15kgs in weight.
 - Shipments over 30kgs will be charged as per our Airfreight Handling Tariff
- Any customs Duty charges applicable on any courier shipments will be charged additionally at actual as assessed by UAE customs.
- The above does not include any additional fees/ charges that may be levied in securing the required permissions from necessary government/ airport authorities required for the customs clearance of the consignment. Charges shown above are one way only (In or Outbound).

6. Port Storage & Demurrage

FREE DAYS & PORT RATES:

- **Air Import**
 - First 48 hours – Free (Final charges as per Airline/ handling Authority)
 - Thereafter - USD 0.10 per kg / day (Min. of USD 20.00 per day)
- **FCL Line Demurrage** per day (at actual/ depends on shipping line). Below rates is indicative only:
 - First 3 days – Free
 - Next 5 days - USD 60\$/20' & USD 110\$/40'
 - Thereafter - USD 170\$/20' & USD 330\$/40'
- **FCL Port Storage** per day (at actual/ depends on shipping line). Below rates is indicative only:
 - First 10 days – Free
 - Next 5 days - USD 25\$/20' & USD 45\$/40'
 - Thereafter - USD 45\$/20' & USD 85\$/40'
- **LCL Port Storage** per day (at actual/ depends on shipping line). Below rates is indicative only:
 - First 3 days – Free
 - Next 10 days - USD 7.00 per CBM per day, Min charge is US\$ 136.24 per day.
 - Thereafter - USD 13.00 per CBM per day, Min charge is US\$ 408.72 per day.

7. Miscellaneous Charges

MISCELLANEOUS CHARGES:

- ✓ Cargo and Transport Insurance.
- ✓ Airline/ Port Storage or demurrage, detention, exchange BL fees, Freezone documentation, hire of any equipment, overtime surcharge, Holiday surcharge or any other special handling, which if applicable will be charged additional.
- ✓ Abnormal/ Unforeseen charges, such as unloading of the container at port for customs inspection.
- ✓ Special handling of oversized or heavy lift pieces (for any Box or Crate, which exceeds more than 2 tons a piece or with dimensions that exceeds 2m x 2m x 1.5m where special handling is required, we will quote our handling charges on a case-to-case basis)
- ✓ Stand dressing, assembly of display panels or exhibits or machinery or decoration of any kind.
- ✓ Cargo subject to approval from any Government Department or Ministry for Importation licenses shall be additional and subject to approval. Charges towards which will be additional.
- ✓ 10% outlay fee will be applicable to all freight collect shipments.
- ✓ Tariff is based on general cargo only, on dangerous/ prohibited/ perishable goods.
- ✓ UAE Customs duty, taxes and outlay fees are excluded.
- ✓ Brochures and Printed materials are subject to approval from UAE Ministry of Information, charges applicable towards securing such approval will be additional.
- ✓ Provision of Packing materials and supply of labour for assistance on the stand.
- ✓ For additional services not listed above, an individual quotation will be given upon receipt of your requirements.
- ✓ Ministry of Foreign Affairs (MOFA) Attestation Charges:
As per New Implementation in UAE, MOFA attestation is mandatory for any shipments which is permanently imported / consumed / non return with a value of above AED 10,000. MOFA attestation charges would be additional".
- ✓ Fixed cost of 0.25% is applicable for VAT service payment for each shipment.
